Notes on the application for 2026-2027 S1 discretionary places

- A. There will be **40** S1 discretionary places in our school (to be confirmed by EDB).
- B. Application Period: 2 – 16 January 2026
Office hours: Monday to Friday: 9:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m.
Saturday: 9:00 a.m. to 12:00 noon

- C. Application procedures:
1. The application form may be obtained in person from our school or downloaded from our school’s website <http://www.oler.edu.hk>.
 2. Please bind the following documents in order and return them to the general office **IN PERSON OR VIA THE SSPA e-PLATFORM** before the deadline:
 - a. the duly completed application form (with photo)
 - b. the “Application Form for S1 Discretionary Place” distributed by E.D.B.
 - c. a photocopy of the H.K.I.D. card
 - d. photocopies of academic reports (P.4 to P.6)
 - e. a photocopy of baptism certificate (for Catholics)
 - f. photocopies of certificates for awards, extra-curricular activities and services (if applicable)
 - g. a self-addressed envelope with stamp (\$2.2) and the student’s name (for application in person)
 3. **There is no need to provide school principal’s recommendation letters of the primary schools.**
- D. Selection criteria:

- E. Interview:
1. All students will be scheduled for an interview.
 2. The interview will be scheduled on **14 March 2026**. Applicants will be notified of the interview date and time either by letter or email (Application via the SSPA e-platform).
 3. The interview will be conducted in English.
- F. Important points:
1. Only girls are eligible for admission.
 2. Once the application procedure is completed, no withdrawal will be accepted.
 3. Each student may apply to **NO MORE THAN TWO** secondary schools (excluding Jockey Club Ti-I College) listed in the “Handbook for Application for Secondary 1 Discretionary Places”. Otherwise, her Discretionary Place application will be rendered void.
 4. Regardless of whether the application is successful or not, the application form and copies of all relevant documents submitted will not be returned. The information provided in the application form will be used solely for the purpose of the application for Secondary 1 (S1) Discretionary Places.
 5. The school will notify parents of all successful applicants of their children’s inclusion in the Successful Lists for Discretionary Places in writing (by letter or email) and by phone on 31 March 2026 (notifications will not be made before this date).
 6. The “School Information Day” is scheduled on 13 December 2025. Please refer to the school’s website for the details about the event.
